Industrials soften as Innscor drifts...


The mainstream Industrial Index slid further by close of Thursday session, trimming 0.20% to 134.76pts. The weakness in the Index was triggered by softening demand in top capitalized stock Innscor which retreated to \$0.4500 after succumbing by a hefty 4.05%. This was the only stock to trade in the negative for the day. The losses were however mitigated by gains in Sugar manufacturer Hippo that emerged as the sole riser with a 0.66% lift to \$0.3800 on resurgent demand. Conglomerate Old Mutual notched 0.41% to \$3.4592 for 7,957 shares while, BAT added 0.33% to trade at \$15.2000 on firming demand. SeedCo completed the risers set with a 0.26% gain to settle at \$0.9525. Overall, four counters gained and one lost value resulting in a positive breadth of three, though the downside outweighed the gainers.

The active stocks count fell by eleven from yesterday's twenty and yielded \$300,411 in value for the day. Econet local LAs emerged the top volume and value contributor of the day after claiming 95.47% of the volume exchanged and 69.72% of the value outturn. Volumes exchanged rose 30.50% to 8.17m shares as values dipped 68.04%. Foreign participation remains subdued as seen in outflows which registered a mere \$200 with no inflows recorded in the session. The Minings closed flat with no activity in the resources sector.
