ZSE closed in the red...

The ZSE slid back into the red in Tuesday trades as all aggregates were down with the benchmark Industrial Index shedding 0.06% to 99.23pts. Weighing on the index were four declines amongst them the heavy cap duo of Delta and Hippo. Star Africa led the casualties of the day after succumbing 17.65% to close at \$0.0070 on the back of 31,000 shares exchanging. Sugar manufacturers Hippo trailed with a 0.50% drop to trade at \$0.1990 while the beverages stock Delta completed the Industrial fallers after giving in 0.37% to trade at a price of \$0.6650. Nine counters were active as the risers and fallers were evenly distributed at four apiece with only one counter trading unchanged. Mitigating the day's losses were gains in heavy caps SeedCo and Old Mutual which added 0.44% and 0.09% and ended pegged at \$0.5700 and \$2.3246 respectively. Axia reversed its previous losses with an 8.70% upsurge while, CFI closed 6.11% up at \$0.0920 as demand persists in the stock.

All aggregates for the day were subdued mirrored in volumes and values outturns which slumped 88.76% and 55.84% to 220,335 shares that yielded \$93,434 in turnover. Axia and Bindura emerged the top volume drivers accounting for 29.69% and 23.91% respectively. Old Mutual and Delta anchored the value outturn with a combined contribution of 88.06% to the aggregate. Foreign flows were similarly depressed though the outturns slightly improved relative to the prior session with inflows accounting for 7.24% while, outflows contributed 7.53% of the turnover. Meanwhile, the less active Mining Index lost 0.62% to 25.56pts dragged down by Bindura which softened 1.79% to trade at \$0.0110, albeit closing with firm demand.


