Industrials rise in subdued Thursday trades...

The industrial index extended gains in Thursday trades despite a rather tepid trading dispensation that prevailed. Activity was heavily subdued with the market spend coming in 96.16% softer at \$0.048m while, a mere 538,097 shares exchanged hands. Volumes were anchored by penny brick makers Willdale that accounted for 55% of the aggregate as SeedCO emerged the most liquid stock for the day having claimed 38% of the total spend. Likewise foreign play was subdued as paltry inflows of \$453.83 were seen against outflows of \$629.40 were seen as the market's capital flight continued


The market none the less stayed in the black in Thursday trades as the benchmark industrial index notched a marginal 0.06% gain and settled at 139.68pts while the less active resources index remained stable at 60.12pts. Property group Dawn led the market charge with a 4% climb to \$0.0130 while hoteliers RTG firmed 0.84% and settled at \$0.0120. Cement manufacturers PPC added 0.40% and ended at \$0.6325 as demand remained firm while Padenga firmed 0.27% and settled at \$0.1855. Completing the top risers for the day was Innscor which added 0.22% and closed the session on \$0.4510.


