Industrials rally continues...

The Industrial Index continues to trend upwards for the eighteenth consecutive session, spurred by gains in twelve risers against a single faller. The main indicator closed 0.47% firmer at 172.28pts while, the Mining Index ended unchanged at 69.63pts with no activity seen in the resources sector. Conglomerate Meikles led the gainers of the day after surging 5.96% to \$0.2755 while top capitalised stock Delta trailed with a weighty 1.82% lift to trade at \$1.0248 as both counters touched an intra-day highs of \$0.2810 and \$1.0300 in that order. Banking group NMB recovered 1.75% to \$0.0348 as sugar refiners Star Africa rebounded 1.69% to \$0.01200. Innscor and Colcom were 0.78% and 0.63% up to end the session at \$0.6075 and \$0.4025 respectively. Econet was the sole faller of the day as the telecom giant plunged 1.40% reversing previous gains to \$0.3599 on profit taking.


The day's activity reflected a mixed outturn as reflected in volumes which slightly improved by 5.1% to 5.02m shares yielding \$1.22m which was down 16.40% from prior session. Barclays led the volumes aggregates with 38.63% of the outturn whilst BAT drove the turnover. The other notable trade was Econet which claimed 11.11% of the value outturn. Foreign inflows contributed 6.3% of the day's turnover while, outflows added 31.94% of the same.
