## Industrials fall as heavies trade mixed...

Mixed trades were witnessed in top capitalized stocks which saw the Industrial Index easing 1.11% to 98.78pts in mid-week trades. Movers for the day were seen in heavy cap stocks namely SeedCo and Old Mutual that traded in the negative while, Delta and BAT trended northwards. SeedCo succumbed 19.89% pts to touch a low of \$0.6350 for a mere 3,210 shares that exchanged hands as selling pressure and weak demand persists on the counter. Conglomerate Old mutual slipped a marginal 0.03% to close the session at \$2.080 despite resurgent demand on the stock. Mitigating the losses were trades in Delta which rose a marginal \$0.93% to \$0.5650 while, BAT notched 0.45% to close at \$10.75. The risers and fallers were evenly distributed at two apiece, though the weight of fallers swayed the market into the red. Econet recorded no trades closing firmly bid at \$0.2410 with no offers. The resources index closed flat at 19.53pts with no trades in the cluster.

Despite the fall in the main indicator, the aggregate turnover improved by 248.78% to 1.53m buoyed by a significant parcel in Delta which contributed 97.99% of the total outturn. On the other hand volume traded was up 92.67% at 2.87m shares with Delta accounting for the bulk claiming 2.66m of the shares traded. Foreign inflows improved by 393% to \$1.46m while, foreign sales surged 360.21%, thus contributing for 92.49% and 97.07% respectively on the turnover. Elsewhere, ZB released a set of an impressive FY15 results which saw the group recording a PAT of \$8.9m which was up 191% and announced a healthy dividend of \$0.00544 per share. The counter saw no trades and was firmly bid at \$0.0250 with no offers in today's session.


