Old Mutual weighs on the industrials...

Old mutual weighed on the market in Tuesday trades as selling pressure in the stock saw the financial services group succumbing 5.98% and closed at 1.7000 with no firm demand. amongst other fallers for the day were retailers OKZIM that topped with a 6.25% decline to a low of \$0.0375 where demand was established. Willdale lost 5% to \$0.0019 for 0.2m shares which exchanged hands. Top capitalised stocks Innscor and Econet let go 2.44% and a marginal 0.2% to settle at \$0.2000 and \$0.1978 respectively. Following the losses in five counters, the main stream Index shed 0.41% reversing yesterday's gains and touched a low of 102.75pts. The market recorded three risers for the day closing with a negative breadth of two. The three risers were, CFI that led with a 5.94% surge to \$0.0606 on a paltry 470 shares, Padenga which added 0.29% to \$0.07 while, Seedco stemmed its decline with a marginal 0.13% increase that took it to \$0.8250.

The day's activity was limited to selected stocks with the value and volume distributions mainly skewed towards the heavy cap Econet, in a session where 12 counters were active. The value dropped 61.77% in which Econet accounted for 98.30%. Similarly, volume aggregates shrunk 50% to 3.42m as Econet contributed 90.10%. Foreign purchases accounted for 29% of the value outturn while, disposals contributed 96% of the same. Foreign outflows at \$0.16m were 75% lower than yesterday while, foreign inflows trimmed 61% to \$0.53m. Meanwhile, the resources index was flat at 19.53pts with only Hwange trading at previous level of \$0.0300 while the rest were inactive.




